The Dean of the Centro Universitário do Sul de Minas, Prof. Dr.hc Stefano Barra Gazzola, in the exercise of his attributions as President of the University Council (CONSUN), pursuant to resolution n° XX, approves the Council's "ad referendum", informs those interested that the applications for the **Virtual Academic Mobility Selection Process** are open to international students for admission in the first semester of 2022 of the subjects listed in ATTACHMENT I (subjects offered), to be held between **February 8, 2022, and July 8, 2022**, according to the specifications contained in this Notice.

1. Courses and subjects

The Selection Process dealt with in this Notice is for the courses described in the tables ATTACHMENT I (disciplines offered), all offered in the virtual modality and in the semester regime.

1.1. Among the subjects described in ATTACHMENT I, some will be offered in English and others in Portuguese. The student, in agreement with their course coordinator and responsible for International Relations of the original Teaching Institution, are free to choose among all subjects offered, being responsible for certifying if the student has sufficient academic background or command of the language to achieve the achievement of the chosen subjects.

- 4.1. Enrollments for the Selection Process will be held from **November 22**, **2021 to January 2**, **2022**, and information can be found on the website: https://internacional.unis.edu.br/
- 4.2. Applications will be made through the website https://forms.gle/ksshDyowHsmZvZGMA, including the requested documentation.
 - 4.2.1. Candidates with special educational needs must indicate, upon registration, the resources they need.
 - 4.2.1.1. The candidate approved in the Selection Process who needs specialized monitoring, declared by a specific report, will be forwarded to the Specialized Educational and Pedagogical Service Nucleus NAEEP at UNIS-MG.
- 4.3. The candidate's registration will imply full acceptance of the norms established in this notice, in the specific legislation, and in the norms of the Centro Universitário do Sul de Minas.

5. ACCESS MODALITY

Access to the disciplines described in **ATTACHMENT I** of this Notice will be given by completing the form described in item 4.2.

- 5.1 It will be up to the Home Institution to verify the veracity of all information provided by the candidate.
 - **5.2.1** Candidates who do not meet the requirements of item 4.2 will be disqualified.

6 CLASSIFICATION

6.1 The deadline for analyzing applications and sending the Letter of Acceptance or Letter of Refusal will be from **January 3**, **2022**.

6 RESULTS

6.1 The result of the Selection Process will be sent through the e-mail registered by the candidate via an acceptance letter.

7 ENROLLMENTS

7.1 The enrollment period for successful candidates will be from **January 3**, **2022 to January 20**, **2022**.

- 7.2 Candidates approved in the Selection Process, observing the deadlines established above, observing the acceptance letter, must pay attention and constantly monitor the receipt of access instructions in their e-mail registered at the time of registration.
- 7.3 The Centro Universitário do Sul de Minas reserves the right to cancel the candidate's enrollment at any time, without reimbursement, if they do not present the necessary documents for the aforementioned process. No document can be replaced by another of any kind.
- 7.4 It is forbidden to enroll the candidate who has not completed Secondary Education, has not completed 18 years of age by **December 31, 2021**, and is not enrolled in the Education Institution of origin informed at the time of enrollment.
- 7.5 The candidate may request the cancellation of their registration, by means of request, within a period of up to 10 days after the beginning of classes.
- 7.6 The candidate may request a change of subject, upon request, within 10 days from the beginning of classes.

8 FINAL DISPOSITIONS

- 8.1 The Centro Universitário do Sul de Minas reserves the right to offer the course in classes taught through conjunctions with other groups, regardless of the period of offer of the discipline.
- 8.2 It is the candidate's duty to correctly inform the physical address, e-mail address, landline, and mobile (cellular) telephones, as well as update them when any data is changed. The damage resulting from the lack or inadmissibility of information in these communication channels is the sole responsibility of the candidate.
- 8.3 The Centro Universitário do Sul de Minas reserves the right, at any time, to transfer the location and hours of operation of courses and subjects.
- 8.4 The Centro Universitário do Sul de Minas reserves the right, at any time, to change the Pedagogical Project of the courses, observing the pertinent legislation.
- 8.5 If there is a change in vacancies, courses or qualifications, by legal acts of the MEC or of the competent Collegiate Bodies, the provisions of these acts will be in force for this Selection Process, as applicable.
- 8.6 The Selection Process governed by this notice is valid only for international entrants to courses at the Centro Universitário do Sul de Minas in the **First Semester of 2022**.
- 8.7 It is reserved for the Centro Universitário do Sul de Minas to adopt the criteria defined by its internal legislation when evaluating an application for taking the performance of studies carried out in other higher education courses.
